ARTICLE X - AMENDMENT

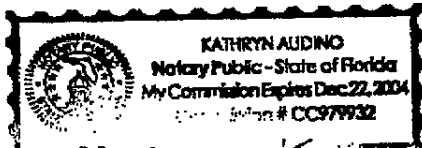


