ARTICLES OF INCORPORATION

OF

HAPPY FISHERMAN ENTERPRISES, INC.

ARTICLE I-Name

The name of this corporation is Happy Fisherman Enterprises, Inc.

ARTICLE II- Principal Office

The address of the principal office is 5643 Lagustrum Lane, Polk City, Florida 33868.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock
