ARTICLE I - NAME EFFECTIVE DATE

The name of this corporation is TURBO WORKS, INC. 1-17-01

ARTICLE II - DURATION AND PRINCIPLE OFFICE

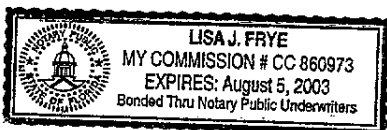
