Article I

The name of the Corporation is "Multi-Resources Development Corporation"

Article II

The duration of the corporation is perpetual.

Article III

The general purpose of the corporation is to provide assistance for professional Nurses, Medical Personnel, Engineers, Seamen and Allied Manpowers, in obtaining employment in the United States and abroad. To engage in any lawful act or activity for which a corporation may be organized under the general corporation law of Florida (GCL), other than the banking business, the trust company business, or the practice of profession permitted to be incorporated by the Florida Corporation Code.

Article IV

The corporation is authorized to issue only one class of stock and the total number of shares which the corporation is authorized to issue is Ten Thousand shares at one dollar (1.00) per share. All of the corporation issued shares of capital stock of all classes shall be held of record by not more than thirty-five (35) persons.
