ARTICLES OF INCORPORATION SECRETARY AND PHOLDINGS, INC.

The name of this corporation is TANNER HOLDINGS, INC.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
