

**ARTICLES OF INCORPORATION
OF
LAKE CITY PROMOTIONS, INC.**

To: State of Florida:

The undersigned, acting as incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as amended, hereby adopts the following Articles of Incorporation for such corporation:

- I. The name of the corporation is **Lake City Promotions, Inc.**
 - II. The period of its duration is perpetual.
 - III. The street address of the initial principal office is 2868 East Baya Avenue, Lake City, FL 32025, and the mailing address of the corporation is 1605 North Ankeny Boulevard, Suite 130, Ankeny, Iowa 50021.
 - IV. The purpose for which the corporation is organized is to engage in all lawful business as permitted by Florida law.
 - V. The aggregate number of shares which the corporation has authority to issue is 100,000 shares of common stock.
 - VI. The number of directors constituting the initial Board of Directors is one and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until their successors be elected and qualify are:


