The undersigned, who is licensed as a physician assistant in the State of Florida, does hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation shall be: MARK BROWNING & ASSOCIATES, P.A.

#### ARTICLE II - PURPOSE

The purposes for which this corporation is formed are:

- A. To engage in the practice as a physician assistant as a professional service corporation.
- B. To own or lease real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of said professional services.
