The undersigned, acting as incorporator of **PEAKIN, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation is **PEAKIN, INC.**

**ARTICLE II: ADDRESS**

The mailing address of the corporation is 730 Southwest 2<sup>nd</sup> Court, Fort Lauderdale, Florida 33312.

**ARTICLE III: COMMENCEMENT OF EXISTENCE**

The existence of the corporation shall commence upon filing of these Articles of Incorporation with the Florida Department of State.

**ARTICLE IV: PURPOSE**

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

**ARTICLE V: AUTHORIZED SHARES**

**ARTICLE IX: BYLAWS**

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders.
