The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

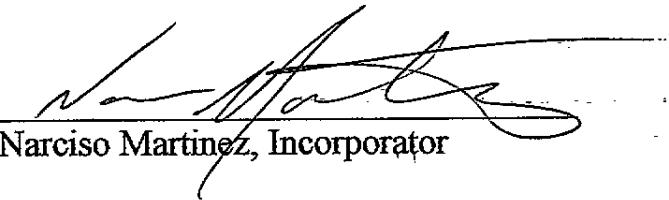

- Article I. The name of the Corporation is Cosmic acceptance corp.

Article X. The corporate existence of the Corporation shall commence on January 1, 2001.

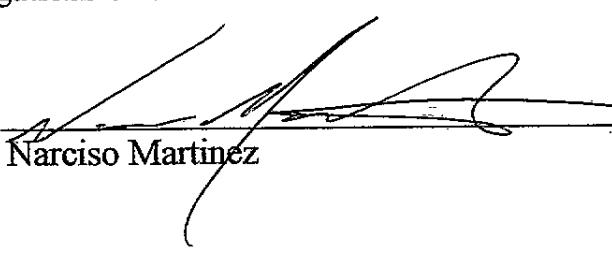
