**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF R & D SOIL BUILDERS, INC.**

Pursuant to provisions of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Name of the Corporation is R & D Soil Builders, Inc.
2. The following Amendment of the Articles of Incorporation were adopted by the shareholders corporation on November 19, 2015, in the manner prescribed by the Florida General Corporation Act:

"The name of the Corporation shall be Florida Soil Builders, Inc."
3. The number of shares of the Corporation outstanding at the time of the adoption was 50, and the number of shares entitled to vote thereon was 50.
4. The number of shares voted in favor of such amendment was 50, and a number of shares voted against such amendment was 0.
5. The manner in which any exchange, reclassification or cancellation of issued shares provided for in the amendment shall be effected as follows: Each outstanding share of stock in R & D Soil Builders, Inc., will be redesignated as one share in Florida Soil Builders, Inc.
6. The manner in which such amendment effects a change in the amount of stated capital and the amount of stated capital as changed by such amendment, are as follows: No change in either.

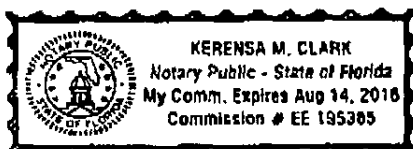
