ARTICLES OF INCORPORATION
OF

ARTICLE I
(name)

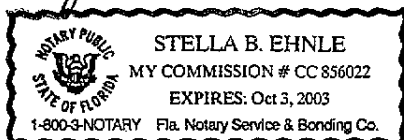
