

Indemnification

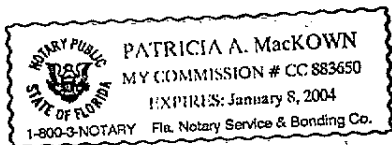


