**ARTICLE I**

**CORPORATE NAME**

The name of this Corporation is A.L. KITCHEN DESIGN OF South Florida, Inc.

**ARTICLE II**

**DURATION**

This Corporation shall have perpetual existence, and shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.

**ARTICLE III**
