ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, being of legal age and natural person, hereby forms a corporation for profit under the laws of the state of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be

ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- A. To engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

- A. The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.
- B. All or any portion of the capitol stock may be issued in payment for real or personal property, services, or any other right or thing having a value, in the judgment of the Board of Directors, at least equivalent to the full value of the stock so to be issued hereinabove set forth, and when so issued shall become and be

fully paid and non-assessable, the same as though paid for in cash; and the directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capitol stock, and their judgment of such value shall be inclusive.

- C. Notwithstanding the foregoing, the corporation shall have the right to increase it's capital stock either with or without par value, and to provide in the event of such increase the designations, preferences, voting powers or restrictions, or qualification of voting powers, of such additional stock, in an amendment to its Certificate of Incorporation.

ARTICLE IV – DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgement of these Articles.

ARTICLE V – PRINCIPAL ADDRESS, INITIAL REGISTERED OFFICE & AGENT
