ARTICLES OF INCORPORATION OF FABULOUS FLORIDA FOLLIES, INC. A FLORIDA CORPORATION

The undersigned, acting as Incorporator of FABULOUS FLORIDA FOLLIES, INC., a Florida corporation, (the "Corporation"), under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME AND ADDRESS

The name of the Corporation is FABULOUS FLORIDA FOLLIES, INC., a Florida corporation, and the street address and initial principal office of the Corporation is 2731 NE 14th Street, #133-B, Pompano Beach, Florida 33062.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transaction any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, or any other state, country, territory or nation.
