ARTICLES OF INCORPORATION
OF
D.L.S. REALTY & INVESTMENTS, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I
Name

The name of the corporation is D.L.S. REALTY & INVESTMENTS, INC.

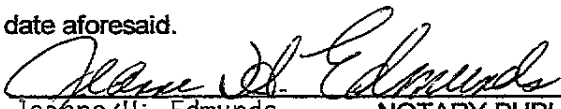
