ARTICLE I. NAME

The name of this corporation is
TREATMENT & PRODUCT ENTERPRISES, INC.

ARTICLE II. DURATION

This corporation shall commence February 1, 2001, and
shall have perpetual existence.

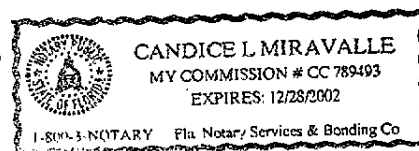
