ARTICLE I - NAME

The name of this corporation is KROON ENTERPRISES, INC., located at 621 Sabal Lake Drive, Apartment 101, Longwood, Florida 32779.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing upon the filing of these Articles Of Incorporation, which shall be the effective date of this corporation.


