Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The date of filing of the articles of incorporation was January 29, 2001, and the assigned document number is P01000011142.
