ARTICLE THREE SHARES

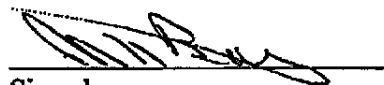

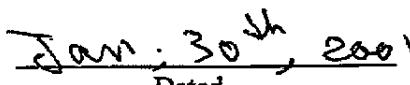

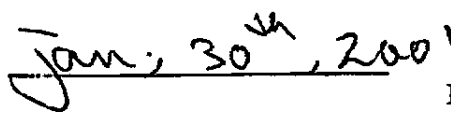
