In compliance with requirements of F. S. Chapter 607, the undersigned, being a natural person, hereby access an incorporator in adopting and filing the following Articles of Incorporation for the organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is: **Jadonco, Inc.**

ARTICLE II

The existence of the corporation shall begin on the date these Articles of Incorporation are filed with the Secretary of State of the State of Florida.

ARTICLE III

The street address of the principal office of the corporation is 689 Lee Hill Road, Milton, Florida 32570.

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is 100, par value one cent per share, all of which shall be in shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which share holders have the right to vote.


The corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.
