BOARD OF DIRECTORS: The initial board of directors shall consist of two members. The names and mailing address of the persons who are to serve as director are:

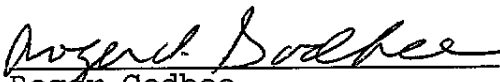
