**ARTICLE I**

The name of this corporation is AUTO TECH RACING, INC., whose principal address is 5821 Funston Street Hollywood, Florida 33023

**ARTICLE II**

The general nature of the business to be transacted by this corporation is to engage in Automotive Repair, a business permitted under the laws of the State of Florida.

**ARTICLE III**

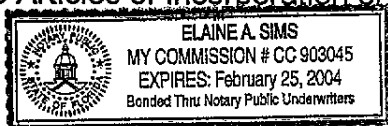





