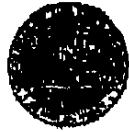

After calling your office, I was told my waiver of the penalty for not filing my 2003 For Profit Annual Report and reinstatement form, which was submitted on April 29, 2004, was rejected, as I needed to have a signature from my current registered agent within 60 days of my application for reinstatement.
