## ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

The name of this Corporation shall be LNS Pet Food ARTICLE ONE: Services, Inc.

ARTICLE TWO: The existence of the Corporation shall be perpetual.

OJ MARIO SA COS SA COS ARTICLE THREE: The nature of the business and the objects and purposes to be transacted, promoted and carried on are to engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act.
