ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

ARTICLE ONE: The name of this Corporation shall be LNS Beverage Services, Inc.

ARTICLE TWO: The existence of the Corporation shall be perpetual.

ARTICLE THREE: The nature of the business and the objects and purposes to be transacted, promoted and carried on are to engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act.

ARTICLE FOUR: The amount of total capital stock of the Corporation shall be divided into three hundred (300) shares with no-par value.

ARTICLE FIVE: The street address of the initial Registered Office shall be 3046 Martin Street, Orlando, Florida 32806, and the initial Registered Agent at that address shall be Richard L. Pietschman, Jr., CPA.

ARTICLE SIX: The street address of the initial Principle Office of the Corporation shall be 2075 Premier Row, Orlando, Florida 32809.

ARTICLE SEVEN: The number of Officers/Directors constituting the initial Board of Directors shall be three. The names and addresses of the persons who shall serve as members of the initial Officers/Board of Directors are as follows:

ARTICLE EIGHT: The name and address of the person signing these Articles of Incorporation as Incorporator is Manny C. Lourenco.

ARTICLE NINE: All of the Corporation's Authorized Capital Stock will be one class "Common Stock" and be considered Small Business Stock under IRC Section 1244.

ARTICLE TEN: All of the issued stock of all classes shall be subject to the following restrictions on transfer. Each stockholder shall offer to the corporation or to other stockholders of the Corporation a thirty (30) day "first right" option to purchase his/her stock.

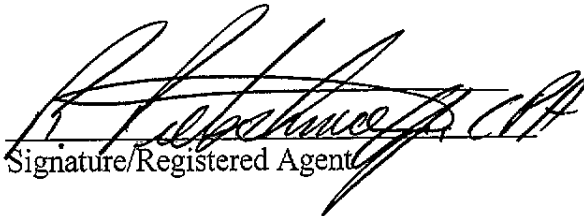

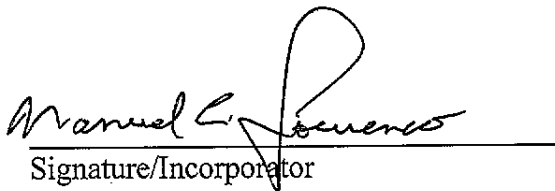
