ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is TREVOR OLSON, P.A.,
whose principal office or mailing address is 207 Montego Inlet
Blvd., Longwood, Florida 32779.

ARTICLE II - DURATION

This corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

ARTICLE X - AMENDMENT

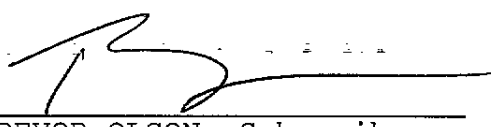
This corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or

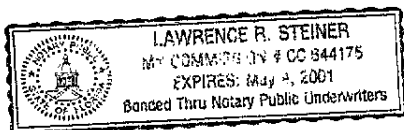

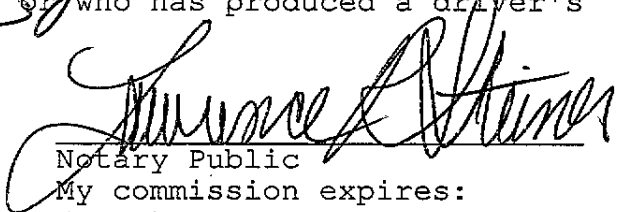

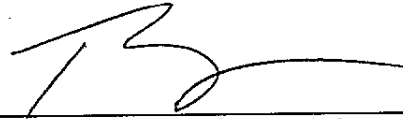
