ARTICLES OF INCORPORATION

The undersigned who is duly licensed to practice law in the State of Florida, desires to form a professional association in accordance with Chapters 607 and 621 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I-CORPORATE NAME AND PRINCIPAL ADDRESS OF CORPORATION

ARTICLE II-PURPOSE




The business of the corporation shall be managed by the shareholders of the corporation rather than by a Board of Directors.

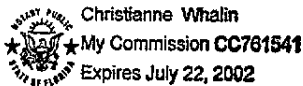
