ARTICLES OF INCORPORATION OF ENTERTAINMENT BUZZ PRODUCTIONS, INC.

The undersigned, desiring to form a corporation pursuant to the laws of the TALLE AFFECTION hereby makes and files with the Department of State these Articles of Incorporation.

ARTICLE I Name

The name of the corporation is ENTERTAINMENT BUZZ PRODUCTIONS, INC. (hereinafter called the "Corporation").

ARTICLE II Duration

The period of existence of this corporation is perpetual.

ARTICLE III Purpose

The purpose for which this corporation is formed is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV Powers

This corporation shall have the power to carry out any and all of its purposes, and said powers shall include, but not limited to, the powers granted under the laws of the State of Florida.

ARTICLE V Capital Stock

This Corporation shall have authority to issue 100 shares of Common Stock having a par value of \$.0.01 per share.

ARTICLE VI Principal Office

or Officer of the corporation at the time he/she is made a party to such action, suit or proceeding, or at the time such cost or expense is incurred by or imposed upon him/her) except in relation to matters as to which he/she shall be finally adjudged in such action, suit or proceeding to have been derelict in the performance of his/her duties as such Director or Officer. The right of indemnification herein provided shall not be exclusive of other rights to which any such person may now or hereafter be entitled as a matter of law.

ARTICLE XII <u>Bylaws</u>

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.
