TO

Radiology Associates of Hollywood, P.A., a Florida corporation (the "Corporation") hereby amends its Articles of Incorporation (the "Articles") for the purposes set forth below in accordance with Florida Statutes § 607.1006:

1. The date of filing of the Articles of the Corporation was January 24, 2001. The Articles of the Corporation were assigned Document Number P01000012275.
2. Article I of the Articles of the Corporation is hereby deleted in its entirety and replaced with the following:

ARTICLE I

The name of the corporation shall be Radiology Associates of Hollywood, Inc.

3. Article III of the Articles of the Corporation is hereby deleted in its entirety and replaced with the following:

ARTICLE III

The purpose for which the Corporation is organized is any and all lawful business.

4. These Articles of Amendment were approved by the affirmative vote of thirty-three (33) of the Company's shareholders. The number of votes cast for these Articles of Amendment was sufficient for approval. The date of adoption shall be March 6, 2015.
5. All of the provisions of the Articles of the Corporation not amended herein are hereby ratified, confirmed, and shall remain unchanged.
