ARTICLE I - NAME

The name of this Corporation shall be: Kingdom Title Services Corporation

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on 02/01/01

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK
