ARTICLES OF INCORPORATION

OF

JOHNSON-KONTOS PROPERTY MANAGEMENT, INC.



Article I - Name

The name of this corporation is JOHNSON-KONTOS PROPERTY MANAGEMENT, INC. and its principal office is located at 21 Suntree Place, Melbourne, Florida 32940.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.
