ARTICLES OF INCORPORATION

On The Come Up Productions, Inc.

The undersigned incorporators, for the purpose of forming a corporation under the Florida. Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE 1: NAME
