OF

ARTICLE I - NAME

The name of this corporation is "CRESCENT IMPORTS, INC."

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing at the time of filing these Articles of Incorporation.

ARTICLE III - PURPOSE
