Article I - Name

The name of the corporation is Ocean Horizion Investments, Inc.

Article II - Purpose

The purpose for which corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the General Corporation Act of the State of Florida. These shall include but not be limited to the power to sue and be sued, complain and defend in its corporate name in all actions and proceedings and to have a corporate seal.
