**ARTICLES OF INCORPORATION
OF
FARIS 1st, INC.**

**ARTICLE I
NAME**

The name of this corporation shall be:

FARIS 1st, INC.

**ARTICLE II
DURATION**

This corporation shall commence its existence upon the filing of these Articles and the duration of this corporation is perpetual.

**ARTICLE III
PURPOSE**

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV
CAPITAL STOCK**
