
ARTICLE X - Liquidation



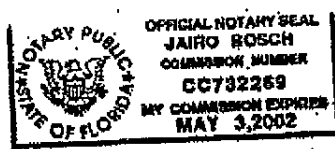


