ARTICLE I – NAME. The name of this corporation is JUMP TO SUCCESS, INC."

ARTICLE II – DURATION. This corporation is to have perpetual existence beginning with the date of subscription and acknowledgement of these Articles of Incorporation which is the 22nd day of January, 2001.

ARTICLE III – PURPOSE. This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV – CAPITAL STOCK. This corporation is authorized to issue 5,000 shares of common stock at \$1.00 par value per share.

ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT.
