The undersigned subscriber to these Articles of Incorporation is a natural person, competent to contract and hereby forms corporation for profit under the laws of the State of Florida

ARTICLE I - NAME

The name of the corporation is **TEL-CARE ENTERPRISE, INC.**

ARTICLE II - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is five hundred (500) shares of common stock, each share having the par value of One Dollar (\$1.00).

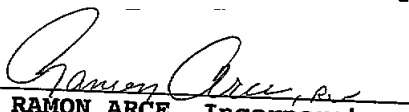

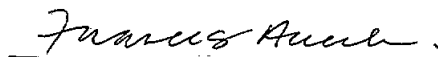
