ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME.

The name of the corporation shall be: Thomas J. Dwork, P.A.

ARTICLE II. ADDRESSES.

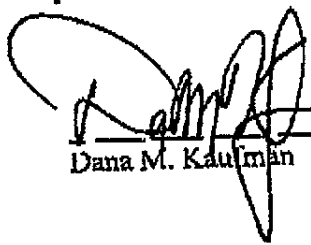
