

# ARTICLES OF INCORPORATION MILKY WAY EXPRESS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General
Corporation Act. does hereby added in Allander and the Corporation and the Corpora Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME
