



For the purpose of forming a corporation under Florida law, the incorporator hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of this corporation is CARLOS RAMOS JANITORIAL, INC.

**ARTICLE II. DURATION**

The duration of this corporation shall be perpetual.

**ARTICLE III. PURPOSE**


