ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME:

The name of this corporation is:

PROMOTIONAL EXPOSURE, INC.

ARTICLE II

NATURE OF BUSINESS:

- (a) The general nature of business to be conducted by the corporation shall be to engage in the development and sale of promotional products, advertisement and marketing with the purpose of distributing premium products and related merchandise services.
