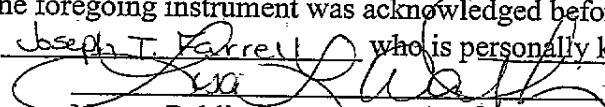
- 1) On July 19, 1999, I incorporated the Law Offices of Joseph T. Farrell, P.A.
