ARTICLE I



Amendments

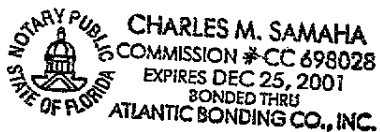
