'BEFORE ME, the undersigned authority, this day personally appeared Jose V Izada & Ignacio Hernandez who first by me being duly sworn deposes and says:

That pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

First: Be it amended that Article of Incorporation Article IX has been changed to resign Ignacio Hernandez as President, Secretary, and Treasurer of the company.

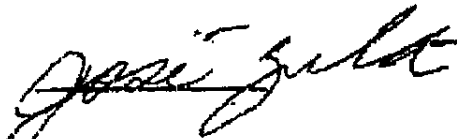
Second: Be it amended that the corporation officers are hereby changed and shall hereafter be known as Jose V Izada as President, Vice-president, Treasurer, Secretary, and Director as well as 100% shareholder of the corporation.

Third: Be it amended that Article of Incorporation Article VI has been changed to correct the Principle and Mailing address to 3200 SW 64 Terrace, Miramar, FL 33023.

Fourth: Be it amended that the corporations Principle and Mailing address are hereby changed and shall hereafter be known as 3200 SW 64 Terrace, Miramar, FL 33023.

Fifth: The date of the change of officers shall be effective on the date filed in the Office of the Secretary of State, Division of Corporations, State of Florida. This is adopted the 26th day of May 2005.
