ARTICLES OF INCORPORATION



The undersigned, for the purpose of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address



The name of the Corporation is RC Dive and Sail, Inc., and the address of the principal office and mailing address of the Corporation is 425 Harbour Drive, Naples, Florida 34103.
