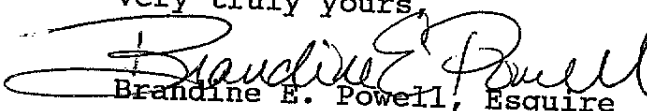

ARTICLE I: The name of this corporation is **Chaos The Auto Saloon, Inc.**

ARTICLE II: The existence of the corporation shall begin on February 5, 2001.

ARTICLE III: The principal place of business of the corporation shall be 8855 Ramblewood Drive, #1810, Coral Springs, Florida 33071.

ARTICLE IV: The maximum number of shares this corporation is authorized to issue is One Hundred (100), all of which shall be common shares. ARTICLE VIII: The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permissible by law.

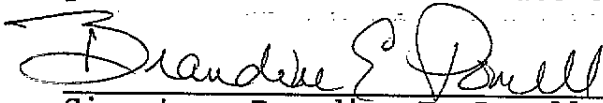
ARTICLE IX: The purpose of the corporation shall be to operate a business in the automobile industry.

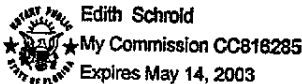
