ARTICLES OF INCORPORATION
OF

ARTICLE I

NAME

The name of this Corporation shall be: S.A. Brady Pilot Services, Inc.

ARTICLE II

EFFECTIVE DATE OF INCORPORATION

The effective date of the incorporation shall be: January 29, 2001.

ARTICLE VII

TERM

The term for which this corporation is to exist shall be perpetual

ARTICLE VIII

OFFICERS

- A. The affairs of the Corporation shall be managed by the President one (1) or several Vice Presidents, a Secretary and a Treasurer and, if elected by the Board, an Assistant Secretary and an Assistant Treasurer, which officers shall be subject to the directions of the Board.
- B. The board shall elect the President, the Vice President, the Secretary, the Treasurer and as many other Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board shall from time to time determine appropriate. Such officers shall be elected annually by the Board at the first meeting of the Board: provided, however, such officers may be removed by such Board and other persons may be elected by the Board as such officers in the manner provided in the By-Laws. The same person may hold two (2) offices, the duties of which are not incompatible; provided, however, the offices of President and Vice President shall not be held by the same person, nor shall the same person hold the office of President who holds the office of Secretary or Assistant Secretary.

ARTICLE IX

FIRST OFFICERS

ARTICLE X

BOARD OF DIRECTORS

- A. The form of administration shall be by a Board of not less than two (2) Directors nor more than fifteen (15) Directors, the exact amount to be determined from time to time by the Board and in accordance with the Plan. The number of Directors initially constituting the Board shall be two (2).

INDEMNIFICATION

Otherwise, the foregoing rights to indemnification shall be in addition to and not exclusive of any and all rights of indemnification's to which a Director or officer may be entitled whether by statute or common law.
