ARTICLES OF INCORPORATION

OF

K.I.T. WIRELESS COMMUNICATIONS, INC.

ARTICLE I - NAME

The name of the corporation is K.I.T. Wireless Communications, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSES

This corporation is organized for the purposes of transacting any or all lawful business.
